



## PG&E Power Charge Indifference Adjustment Rates

(effective May 1, 2020)

The Power Charge Indifference Adjustment (PCIA) is a charge assessed by PG&E to cover generation costs acquired prior to a customer's change in service provider. This fee is collected by PG&E and is effectively an "exit fee" assessed to customers which receive their generation services from another provider. PG&E assigns customers a "PCIA Vintage" based on the date they were enrolled in alternative service. Customers can find their vintage on the PG&E Electric Delivery Details page of their bill. These rates are updated each January by PG&E.
