  - Bulk pricing and volume discounts are clearly documented

#### **Site Eligibility Confirmation**

- Consultant will verify site eligibility after SCP has confirmed customer eligibility, ensuring that:
  - The site has a functional central air conditioning system
  - The site is safe for the Consultant to perform work

#### **Installation and Configuration**

- Consultant will install and configure smart thermostats to ensure full integration with the existing HVAC system
- Enroll the smart thermostat in SCP's GridSavvy Rewards program
- Provide a homeowner tutorial on thermostat operation, programming, and energy-saving settings, including answering technical questions and assisting with enrollment of the smart thermostat into SCP's GridSavvy program for demand response participation

#### Post-Installation Summary and Reporting

- After installation, the Consultant will prepare and submit a comprehensive report for each site to SCP. The report should include details of the thermostat installation
- Submit the drafts of each assessment to SCP for review and potential feedback
